Glenn has played in 10 championship series and has come out on the winning end 6 times. He was named to the All Star Team six times. Glenn was named First Team All-NPSL and Defender of the Year runner up in 2001. He has been a member of the U.S. National Futsal Team since 1996. Glenn was a four year starter at Rutgers University and a Parade High School All-American. He still holds the high school state record for most goals in a season with 67. Glenn was named SOCCER PLAYER OF THE DECADE OF THE '80'S by the Atlantic City Press and was inducted into the South Jersey Hall of Fame in 1995
